## DEPOSIT AND FULL PAYMENT INFORMATION

To reserve this workshop, a \$500 per person deposit is required, along with the Registration Form and Responsibility Clause. These fillable forms are located on the website. Deposits must arrive by January 31st, 2024. Each person attending is required to fill out both documents, sign them and return with their deposit.

Reservations are on a first come, first serve basis. Once openings are filled, your name will be placed on a waiting list. If there is a cancellation, you will be contacted. A deposit and both documents will be required at that time to reserve your spot.

Full payment is due February 28th, 2024. **Please pay your balance by check. Credit card payments will require an additional 4% to cover the processing fee.**

## CANCELLATION POLICY

Cancellation requests before the deposit deadline of January 28th, 2024 will be refunded minus a \$50 administration fee.

Cancellation requests prior to the full payment date of February 28th, 2024 will forfeit the \$500 deposit.

Cancellation requests after the full payment deadline of February 28th, 2024 must be made in writing to [wiegardtwatercolors@gmail.com](mailto:wiegardtwatercolors@gmail.com). No money will be refunded unless the space can be resold. If the space is resold, you will be refunded all monies paid minus the \$500 deposit.

No refund will be given to an applicant who does not participate or complete the workshop or field activities.
